## When Movements Go Beyond Control: **World Movement Disorder Day**

ovement disorders are neurological conditions that disrupt the brain's control of are moviluntary and involuntary movements. They cause abnormal movements like spasms, jerking, rigidity, or slowness are caused because of damage to or malfunction of the areas of the brain

that control movement.

Movement disorders account for 3-8% of neurological conditions in India among people over 60 years. Approximately 31 to 45 out of every 100,000 individuals over 60 years are af-

fected by movement disorder. These conditions are more commonly seen in rural areas of India.

Movement disorders can be categorized in several ways, including but not limited

> Blepharospasm - frequent or forceful blinking that can make it hard

Hemifacial spasm - twitching or tightening on one side of the face.

Cervical dystonia - uncontrollable squeezing movements in the face and neck

"Cervical bytonia makes the neck movements beyond one's control. Even simple moments: turning to greet someone or nodding yes - feel painful and exhausting. Mary live through this misery silently, not knowing what is alling them. Even if they become aware of the condition, they don't know help exists. With early diagnosis and timely treatment, the pain can ease, movements can return, and life can feel lighter again. Even painet deserves that relief - to look up, move freely, and live with comfort once more."

"Frequent eye blinking is often mistaken for dry eyes, especially when accompa-nied by redness. However, in some cases, the real cause may not be dryness, but a con-ditional feel blepharospasm. Using lubricating eye drops or gels may not provide re-lief, as the problem lies in the muscle control rather than eye dryness. There are therapies which offering faster and longer-lasting relief."

"Hemifacial spasm is a neurological condition that causes involuntary twitching or contractions on one side of the face, usually starting around the eye and spreading to the lower face. It is most often caused by a blood vessel pressing on the facial nerve (7th cranial nerve) near the brainstem. There are long-term cure available which helps in relieving the pressure on the 7th nerve."

Early consultation with a neurologist with spe-cialization in movement disorder can help pa-tients regain control & restore movement. To know more, visit your nearby Neurologist.
